CHANCEFORD TOWNSHIP**

**MEETING DAY & TIME:** January 2, 2007

David Gemmill opened the reorganizational meeting of the Chanceford Township Board of Supervisors at 7:05 p.m. in the Community Bldg., 51 Muddy Creek Forks Rd., Brogue, PA with a moment of silence in remembrance of former President Gerald R. Ford. He led those in attendance in the pledge to the flag.

Members present: David Gemmill and Eric Bacon.

Eric Bacon was appointed temporary chairman by a motion from Eric Bacon, seconded by David Gemmill. Motion was voted on and carried.

Brenda Gohn was appointed temporary secretary by a motion from David Gemmill, seconded by Eric Bacon. Motion was voted on and carried.

A motion was made by Eric Bacon, seconded by David Gemmill to appoint David Gemmill chairman. Motion was voted on and carried.

David Gemmill made the motion to appoint Eric Bacon vice-chairman. Seconded by Eric Bacon, motion carried.

A motion was made by David Gemmill, seconded by Eric Bacon to appoint Brenda Gohn secretary-treasurer. Motion was voted on and carried.

A motion was made by David Gemmill, seconded by Eric Bacon to retain M&T Bank and PLGIT as depositors for the township funds. Motion was voted on and carried.

A motion was made by David Gemmill, that he would remain the emergency management coordinator in the interim. Seconded by Eric Bacon. Motion was voted on and carried.

A motion was made by David Gemmill, seconded by Eric Bacon to appoint Henry Tyson voting delegate to the State Convention. Motion was voted on and carried.

A motion was made by David Gemmill, seconded by Eric Bacon to approve paying attendance and mileage to attend the State Convention. Motion was voted on and carried.

A motion was made by David Gemmill, seconded by Eric Bacon to pay other actual expenses for the attendance at the State Convention. Motion was voted on and carried.

A motion was made by David Gemmill, seconded by Eric Bacon to compensate employees at the regular employee rate to attend the State Convention. Motion was voted on and carried.
