MEETING DAY AND TIME: August 23, 2010

Eric Bacon opened the meeting of the Chanceford Township Board of Supervisors at 7:05 p.m. in the Community Bldg., 51 Muddy Creek Forks Rd., Brogue, PA. He led those in attendance in the pledge to the flag.

NEW BRIDGEVILLE MEMORIAL FIRE CO.:

The Standard Operating Procedures manual, By-laws manual and financial statement were submitted to the Board for their review.

The New Bridgeville Memorial Fire Co. was present to let the Board know that they are going back to first due in Chanceford Crossings in which case Felton Fire Co. will then be relegated to second due. They stated that this decision was made after learning that Felton Borough invoiced Chanceford Township for a portion of their workmen's compensation for years 2008, 2009 and 2010. They contemplate this change being accomplished before the first of the year. Also, all fund raising solicitations in Chanceford Crossings will then be conducted by New Bridgeville Memorial Fire Co.

They will have all the box changes by the next meeting for the Board's approval. The Board has no objection to these changes as long as there are no residents put in jeopardy. Kent Heffner asked if Felton Fire Co. is still going to respond. Daryl Miller stated that Felton Fire Co., as before, will continue be on the initial dispatch. It was commented that it will be at Felton Fire Company's discretion whether or not they want to respond. New Bridgeville Fire Co. is going to add Airville and Craley Fire Companies to the call box in Chanceford Crossings to assure adequate coverage. In addition, they are considering adding Yoe and Windsor Fire Companies as well. They feel that the response time would be no different from the station to Chanceford Crossings then it

A letter was also received from the Felton Fire Co. requesting additional funding to help defray the cost of a recently purchased brush truck. This is in addition to the 2010 budgeted donation of \$8,800.00.
