Chanceford Township, York County Board of Supervisors Regular Meeting

MEETING DAY AND TIME: March 14, 2016

Kent Heffner opened the meeting of the Chanceford Township Board of Supervisors at 7:00 p.m. in the Community Bldg., 51 Muddy Creek Forks Rd., Brogue, PA. He led those in attendance to the pledge to the flag.

Members present: Chairman Kent Heffner, Vice-chairman Bradley Smith and Member Clifton Baldwin.

Others present: Solicitor Timothy Bupp, Engineer Grant Anderson, Zoning Officer Jeffrey Koons, and Secretary Treasurer Danielle Dehoff.

APPROVAL OF MINUTES:

Brad Smith made the motion to approve the minutes of 2/29/16 as written, seconded by Clifton Baldwin, motion carried unanimously.

Kent Heffner made it known that there were three work sessions with no decisions made at any. The dates of those work sessions are as follows:

- o March 1, 2016- Auditors requested a meeting- the Supervisors held no discussion
- o March 9, 2016- New drafted handbook was handed out- no decisions were discussed by the Supervisors
- o March 14, 2016- Employees- no decisions were discussed by the Supervisors

NEW BRIDGEVILLE FIRE CO:

Ronald Witmer reported that there were 17 calls in the month of February with 14 of them being in the Township.

FELTON FIRE CO.:

Felton Fire Co. did not have a representative present for this meeting.

SYCEMS:

SYCEMS reported that there were 125 calls in the month of February with 22 of them being in the Township. There will be another training held April 14, 2016 at Airville.

SUBDIVISION AND SUBMITTAL PLANS:

- **Barley Farms** (13845 Ted Wallace Road--30,710 S.F. Heifer barn expansion and a 100 ft diameter (7,850 S.F.) concrete manure storage facility).
 - o There has been no NPDES approval submittal or financial security amount given to the Attorney for approval.
 - Kent Heffner made a motion to table this plan until April 2016, seconded by Clifton Baldwin; motion carried unanimously.
- **Steven Myers-** (Waughtel and Main Street Extended) -- He will be subdividing a 4.787 gross acre lot and a 2.95 gross acre lot.
 - o Brad Smith made a motion to approve the one waiver, seconded by Clifton Baldwin; motion carried unanimously. Waiver consists of:
 - 1. New deeds shall be written and recorded with the plan to allow the tax map to be updated.

- o Brad Smith made a motion to approve this plan contingent on the two open conditions being addressed, seconded by Clifton Baldwin; motion carried unanimously. Conditions are as follows:
 - 1. Section 502.e & 602.e- Proof of planning module approval by PA DEP shall be provided to the Township
 - **2.** Payment of all fees

PUBLIC COMMENT:

- Station Manager, Trooper Nicole Palmer was present to introduce herself to the Board of Supervisors as well as to give a brief summary of offenses in the last year. The summaries are as follows:
