Lieutenant Spingler was present and gave a report regarding police activity in the Township since January 2023.

NEW BRIDGEVILLE FIRE CO:

Kent Heffner stated in May there were a total of 21 calls in the Township, 10 were medical.

ALLIANCE FIRE & RESCUE SERVICES:

Tyler Burkins stated in March there were a total of 85 calls, 3 in the Township, 2 were medical.

SOUTHERN YORK COUNTY EMS, INC. REPORT:

Eric Bacon stated in May there were a total of 129 calls, 26 calls in the Township, 2 received mutual aide, gave a mutual aide 16 times.

YORK ENERGY STORAGE: (Cuff's Run)

Tim Bupp gave an updated regarding the status. On May 8th York Energy applied for a 30-day extension. FERC granted the 30-day extension until June 17th. FERC has received many letters of opposition from various groups.

BUILDING CODE / ZONING REPORT:

Kevin Hertzog was present and gave an update on current permits and permits that are in transition from South Penn Code and need completed. He presented the board with Zoning Fee Schedule for review.

Patsy Curran stated her concerns with the property at 2705,2707, 2079 Delta Road. She provided pictures of property. Building has not be completed. Information was forwarded to South Penn Code.

Tim Bieber from Rutter's was present, and gave the Board copies of the Developers Agreement Storm Water Agreement executed by Rutter's. They have installed a meter on the well and are monitor the water usage.

Inlet and culvert pipe project on Old Bridgeville Road has been completed.

The FEMA work on Kline Road consisting of saw cutting, digging out and basing in and paving has been completed.

The FEMA work on Hill Top Road is still in process and is about 50% complete.

The road crew assembled 2 steel picnic tables and 1 bench which were purchased by the Recreation Board and placed them at the Conrad's baseball fields.

A resident at Chanceford Crossings has volunteered to open and close the gate at the Recreation Area every morning and evening. We have had a vandalism to the building and tearing up of the parking lot. Residents state that there is traffic in an out of the parking lot all night long.

The 1999 Mack is in the shop and going over it for inspection. Parts have been ordered for the roller.
