APPROVAL OF MINUTES:

Ross Strack made a motion to approve the minutes dated March 19, 2024 as presented. Seconded by, Marla Allen and the motion carried.

SUBMITTALS & SKETCH PLANS:

Maple Springs Farms – Tom and Stacy Burchett were present to discuss the transfer of dwelling rights from Parcel 52 to Wolfe Road.

Bruce Miller made a motion to recommend approving the transfer of two (2) dwelling rights from Bender Farm parcel 52 to parcel EM-29 Wolfe Road. The Maple Springs Farm Subdivision dated June 8, 2020 parcel 52 shows four (4) dwelling rights, Tom and Stacy Burchett have requested to transfer two (2) dwelling rights from Parcel 52 to parcel EM-29 Wolfe Road, both parcels are prime soil high quality soil. It is noted that the applicants stated the building rights were not included in the Bender Road farm (parcel 52) land preservation sale and amount of farm land preservation funds was reduced. It meets the terms of the Ordinance. Seconded by, Mark Bupp and the motion carried.

Lane Corbett was present to discuss a possible subdivision and placing it in Farm Land Preservation for his property at 80 Corbett Lane. It was recommended for Mr. Corbett attend a Supervisors meeting to discuss a waiver regarding the driveway access, as there are 3 properties using access.

John Urey was present to discuss straightening his property lines on Oscars Road. A subdivision would need to be done.

Zoning Officer Report:

Bruce Eveler from Chanceford Township was present to discuss the possible expansion of the airport to reduce the Township Liability. And expanding the hangers.

OTHER BUSINESS:

Grant Anderson reviewed the comments on the Zoning Ordinance Amendment that were received from York County Planning.
